Effective January 1, 2019, the minimal wage in California is \$12.00 per hour. To receive 100% of your escrow credit, you must be "suitably employed" on the last day of your FSS contract. "Suitable employment" is defined as earning the equivalent of someone working thirty-two hours a week at the prevailing minimal wage.

Prior to January 2019, suitable employment was comparable to earning \$352 or more a week. Effective

January 1, 2019, suitable employment is comparable to earning \$384 or more a week. This applies to self-employment as well.

As a reminder, there are three criteria that a FSS participant must meet on the **last day of their FSS contract** or graduation date: (1) Suitable employed, (2) TANF-free (welfare) for twelve consecutive months prior to contract end date and (3) meet all of the ITSP goals.


