Winston Gardens Access Control and Video Surveillance Project

This project was developed to improve safety and security at Public Housing property 43-10, Winston Gardens.

- Plans and specifications documents were prepared by HMR Architects.
- Sitework: Installation of new ornamental iron fence and repairs to existing ornamental iron fencing; Installation of ornamental pedestrian gates including the hardware and access control infrastructure; Installation of ornamental iron maintenance gate; Installation of ornamental sliding gates at driveways including controller and necessary infrastructure for access controls; Replacement of chain link vehicle gate; Concrete curbs and walks at pedestrian and sliding gates; Replace site lighting and trellis light fixtures; Install power and infrastructure for access controls and security cameras provided by others
- This project is expected to start late Fall 2024, with completion in Spring 2025.
- On August 15, 2024, three (3) contractor bids were received, two of the bids significantly exceeded the budget and the third was non-responsive, therefore a decision was made to resolicit the project for new bids.
- On September 5, 2024, the HACB received one responsive and responsible bid in the amount of \$496,711.00, this amount exceeded the independent cost estimate by 2.32% and is considered reasonable.

# AUTHORIZATION TO ENTER INTO CONTRACT WITH BIRCHARD CONSTRUCTION, INC FOR WINSTON GARDENS ACCESS CONTROL AND VIDEO SURVEILLANCE PROJECT

WHEREAS, the Housing Authority of the County of Butte (HACB) owns and operates Public Housing under Annual Contributions Contract with the United States Department of Housing and Urban Development (HUD); and

WHEREAS, HACB annually receives Capital Fund appropriations from HUD for purposes of making physical improvements to HACB's Public Housing properties; and

WHEREAS, the HACB has determined that increasing video surveillance; improving access control; and improving lighting, at Public Housing Property 43-10 Winston Gardens are necessary for reasons of safety and security; and

WHEREAS, the HACB has solicited bids for Winston Gardens Access Control and Video Surveillance Project in accordance with its Procurement Policy; and

WHEREAS, the bid received from Birchard Construction, Inc., in the amount of Four Hundred and Ninety-Six Thousand, Seven Hundred and Seventy-One Dollars and No Cents (\$496,771.00), has been determined to be the lowest responsive qualified bid received and to be in the best interest of the HACB; and

WHEREAS, the Board of Commissioners of HACB (Board) has established procurement policy such that contracts greater than Two-hundred and Fifty Thousand Dollars (\$250,000.00) must be authorized by resolution of the Board;

THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Housing Authority of the County of Butte to authorize the entering into of a contract with Birchard Construction, Inc., in the amount of Four Hundred and Ninety-Six Thousand, Seven Hundred and Seventy-One Dollars and No Cents (\$496,771.00), for completion of the Project, such contract compensation to be paid for with HUD Public Housing Capital Fund monies secured under Capital Fund Emergency Safety and Security Grant 2023 and Capital Fund 501-2023
